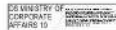

- (6) that nothing in clauses (3), (4) and (5) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company;
- (7) that no alteration shall be made to the memorandum of association or to the articles of association of the company, which are for the time being in force, unless the alteration has been previously submitted to and approved by the Registrar ;
- (8) The Company can be amalgamated only with another company registered under section 8 of the Act and having similar objects; and
- (9) that, without prejudice to action under any law for the time being in force, this licence shall be liable to be revoked, if the company:

  - (iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.
  - (v) Nothing in clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company;

**PRELIMINARY**

1. Subject as hereinafter provided the Regulations contained in Table 'F' in the First Schedule to the Companies Act, 2013 shall apply to the Company.

**INTERPRETATION**

2. In these regulations:
  - a. "Company" means "PRIME HUMAN RIGHTS FOUNDATION".
  - b. "Office" means the Registered Office of the Company.
  - c. "Act" means the Companies Act, 2013, and any statutory modification thereof.
  - d. "Seal" means the Common Seal of the Company.
  - e. "Directors" means the Directors of the Company and includes persons occupying the position of the Directors by whether names called.
3. Unless the Context otherwise requires the words or expressions contained in these regulations shall bear the same meaning in the Act, or any statutory modification thereof in force on the date at which the regulations become binding on the Company.

**PRIVATE COMPANY**

4. The Company is a "Private Company" within the meaning of Section 2(68) of Companies Act, 2013 and accordingly the following provisions shall have effect namely: "Private company" means a company having a minimum paid-up share capital as may be prescribed, and which by its articles,—
  - i. restricts the right to transfer its shares;
  - ii. except in case of One Person Company, limits the number of its members to two hundred: Provided that where two or more persons hold one or more shares in a company jointly, they shall, for the purposes of this clause, be treated as a single member;

Provided further that—

- A. Every founder-member of the company and every other member who may hereafter be willing and shall be admitted or re-admitted shall signify in writing:
  - (a) that he assents to the Memorandum of Association and rules and regulations of the company
  - (b) that he will conform to and be bound in all respects thereby;
  - (c) that he authorizes the company to enter his name in the Register of Members of the company.

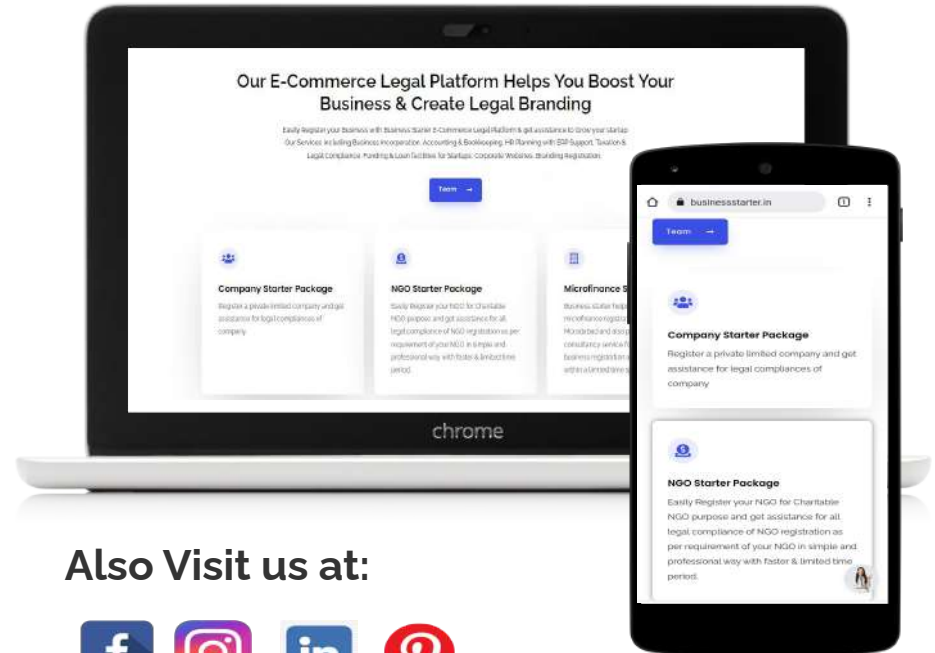
